

Incident Descriptions

Assault

An attack by one person upon another



Assault with Deadly Weapon

An attack by one person upon another for the purpose of inflicting severe/aggravated bodily injury



Sexual Assault

The forcible assault of a sexual nature on another person



Sexual Offense

Offenses against chastity, common decency, morals, or a similar nature



Other Sexual Offense

Offenses that are sexual in nature but not classified as a sexual offense or sexual assault



Homicide

The willful killing of a human by another



Kidnapping

Seizing and carrying away a person by force or fraud, or detaining a person against his or her will with an intent to carry that person away at a later time



Robbery

Taking or attempting to take anything of value from the care, custody, or control of a person



Breaking & Entering

The entry of a structure to commit a felony or a theft



Property Crime Commercial

General crimes committed on commercial property



Property Crime Residential

General crimes committed on Residential property



Other Property Crime

General crimes committed on residential or commercial property



Theft from Vehicle

Theft of articles from a motor vehicle



Theft of Vehicle

Thefts of all classes of motor vehicles that serve the primary purpose of transporting people



Other Theft

Taking or attempting to take anything of value from the care, custody, or control of a person



Disorder

Any behavior that tends to disturb, scandalize, or shock the public peace, decorum, or sense of morality



Drugs

Violation of laws prohibiting the production, distribution, and/or use of certain controlled substances. Includes the equipment or device used in their preparation and/or use. Cultivating, manufacturing, distributing, selling, purchasing, using, possessing, transporting, or importing any controlled drug or narcotic substance.

Liquor

Driving or operating a motor vehicle while impaired as the result of consuming an alcoholic beverage or using a drug or narcotic

Quality of Life

General incidents related to drugs, liquor, and disorder

Community Policing

Engaging criminals or violators before they commit a crime

Proactive Policing

Engaging criminals or violators before they commit a crime

EMS

Natural or manmade disaster or emergency where public safety officers respond

Fire

A fire that public safety officers responded to

Alarm

A fire alarm






Mud 120 Area Crime June 2025




